The Kansas City Club, established in 1882, was one of the Midwest's premier social clubs. The club was originally organized for the "purpose of cultivating social and business associations among the leading business professionals in Kansas City." After growing its membership past limitations of their first building, the Club built a clubhouse at the corner of 13th and Baltimore Avenue in 1922. This building, known as the Kansas City Club Building, stood in the heart of Kansas City's downtown business district for the next 80 years. Some of the more notable individuals associated with the club include Harry S. Truman, Dwight D. Eisenhower, General Omar Bradley, and Ewing Kauffman. Early members helped shape the social and economic landscape of Kansas City. Starting in May 2019, the building began a year and a half of renovations, with the Hotel Kansas City hosting its grand opening in October 2020. The 15th floor, which held an outdoor garden, was transitioned into downtown Kansas City's only indoor/ outdoor events-specific venue. Tickets available (\$50), until sold out, at registration. **Downtown Planning for Dummies** 



The process of downtown programming is a corridor activation process that will help Main Street organizations program the location and disburse retail, services, or amenities throughout a downtown. Many communities currently suffer from what is termed "hot spot" issues. This is caused by the consolidated development efforts of single blocks or small corridor areas. While it is great that these services are successful, it leaves the remainder of the corridors in poor condition. Understanding this is a detriment, the downtown programming training will provide tips, tricks, and strategies for conducting a gap or market analysis with publicly available data; determining the necessary mixture or distribution of services to make downtown the HUB of activity; documenting available spaces or amenities and their locations in an asset-based mapping format; and outlining strategies for partnerships or capacity improvement to guide development.



In 2006, Jason helped to revive the Dallas streetcar system. He later spearheaded the city's effort in garnering a \$23 million dollar grant from the federal government to help reintroduce a modern streetcar system to Dallas. In 2010, Jason organized a series of "Better Block" projects, taking blighted blocks with vacant properties and converting them into temporary walkable districts with pop-up businesses, bike lanes, café seating, and landscaping. The project has become an open-sourced international movement featured in the New York Times, Washington Post, and Dwell Magazine. Jason has received a Champions of Change award from the US White House and has been showcased internationally for his work.

INDIA WELLS-CARTER, inspired by Kansas City's rich art culture and feel-good Midwestern vibes, sought to create a fresh, novel social experience for all to enjoy at Fresh Factory KC. A good selfie and a great party are just a few things India loves to celebrate! Prior to entrepreneurship, India served in a variety of educational nonprofit leadership roles within the region. She began her career with the University of Missouri-Columbia (her alma mater) and transitioned to the Kauffman Foundation, TNTP (formerly The New Teacher Project), and has since led local nonprofit programs supporting Kansas City students, educators, and families in KC. India is a champion for all people and seeks to ensure everyone has access to pursue their dreams -- like she did! She couldn't live her dreams without the support from her husband, inspiration from her son, and love of her community.



CHRIS GOODE is the founder of Ruby Jean's Juicery based in Kansas City, MO. Chris is a passionate entrepreneur who started his company in 2015 to honor the early death of his Grandmother Ruby Jean, who fought a short-lived battle with Type 2 diabetes. He adamantly believes if his grandmother had the knowledge of juicing and a healthy lifestyle, she would still be alive today. In addition to formerly serving on the Kansas City Parks & Rec board of commissioners where he was able to impact many areas of Kansas City, Chris recently launched a partnership with Kansas City Public Schools to provide fresh juice to three schools in a first-of-its-kind national pilot program. Chris also stands as the first person to ever attend Operation Breakthrough, a Kansas City community child-care center that provides a safe, loving, and educational environment for children in poverty, and now serves on their board of directors. Ultimately Chris has taken the platform of

Ruby Jean's over its first seven years of business and leveraged it to generate tangible change and health awareness consistently throughout the Kansas City community and beyond.






